In 1972, Potomac Hospital in Woodbridge, Virginia was opened as the result of the grassroots efforts of local concerned citizens who recognized that residents in our community did not have ready access to acute health care services. The motto of these local citizens while raising funds and support for the community hospital was, "A Life Is Reason Enough." Once the hospital was established, the services provided there were dictated by the needs of the community.

Potomac Hospital delivered care to the community until 2009 when a merger with Sentara Healthcare occurred. Following that merger, a new role evolved the Potomac Health Foundation. For the past six years, the Foundation Board of Directors has endeavored to maintain the legacy and spirit of Potomac Hospital's 40 years of service to the community. The Foundation has distributed over \$23 million in grant dollars in Eastern Prince William County, North Stafford and Southeastern Fairfax. The Foundation's grant making has been to those issues of greatest need to the community by focusing on access, prevention, and innovation.

As the Potomac Health Foundation reflects on the work of our first five years and plan for the next five, we are pleased to present our annual report which highlights the Foundation's investments in the many dedicated area agencies and programs working to improve the health of our community in 2014-2015.

Within these pages you will find snapshots of the grantee organizations whose tireless staff work every day to improve the health of the community because "A Life is Reason Enough." Whether keeping the children of the community healthy and active or providing families in need primary health care, the men and women working across the community to improve the health of your colleagues, sons and daughters, and neighbors are doing so with a compassion that suggests despite the years that have passed and changes that have come to the community since 1972, things have not changed that much after all.

ABOUT THE FOUNDATION & SERVICE AREA



Potomac Health Foundation was established in 2009 as a result of the merger between Potomac Hospital and Sentara Healthcare, Inc. Potomac Hospital used proceeds from the merger to establish the Foundation. The Foundation started its grant making in 2011. The mission of the Foundation is to improve the health of the community by increasing access to primary health care for the medically underserved, reducing the incidence of preventable diseases, and supporting innovation around emerging health needs. Health Safety Net (HSN) Program: The Health Safety Net program was started in 2014. Through this window, the Foundation grants awards to agencies making up the health safety net for the medically underserved in the community. This includes access to primary, dental, medication, mental health, vision or other health programs designed to increase access. These grants are made on an invitation only and annual basis and there is no limit to number of years funded.

In order to address these, the Foundation makes several types of grants.

Howard L. Greenhouse Large Grant Program: The signature grant program of the Foundation makes three-year project-based grants on an annual basis through an open Request for Proposals (RFP) process. The inaugural Large Grants were made in 2011. The Large Grants address a variety of health issues focusing on access, prevention, and innovation. Many projects initiated with funding by a Howard L. Greenhouse Large Grant have been sustained with other resources.

Prince William Area Free Clinic

HEALTH SAFETY NET SERVICES ENSURE THAT THE MOST VULNERABLE MEMBERS OF OUR COMMUNITY DO NOT GET LEFT BEHIND AND ARE ABLE TO GET THE CARE THEY NEED

The Foundation is committed to ensuring access to primary health care services for community members who have difficulty doing so because of cost and insurance barriers. The Foundation addresses much of this need through its Health Safety Net (HSN) grants. HSN grants fund general operating support for agencies who provide much needed health care services for medically underserved. One of those agencies is the Prince William Area Free Clinic, located in Woodbridge, Virginia. The Free Clinic serves uninsured residents of Prince William County who earn 125% or below of state poverty guidelines. The Clinic provides a permanent patient-centered medical home to residents of Prince William County. Services are free of charge to clients and include diagnostic studies, specialty care and referrals, dental care, mental health services, case management, patient education, medication access, and preventive care. In 2014, the Clinic had more than 17,000 patient visits. The Clinic managed these patient visits while maintaining high quality of care, decreasing wait times, and accommodating an increased number of walk in clients over previous years. Many of the patients who have made the Free Clinic their medical home have stopped using the emergency room as their primary source of care and have also taken advantage of extended Free Clinic hours, enabling them to schedule visits as not to miss days of work and earned pay.

PREVENTION

Prince William Soccer Courage Fun

In order to address the increasing issues around obesity and related health conditions such as Type II diabetes in young people in the community, the Foundation made a grant to the Prince William Soccer Courage F.U.N. program. The Courage F.U.N. program is a preventative program, tackling issues of obesity and Type II diabetes before they occur. The program meets children where they are as it takes place after school at Title I area elementary schools where a high

percentage of students are in poverty. Students at these schools from ages eight to ten are invited to participate. In collaboration with school officials, trained coaches engage the students in physical activity through various soccer skills three days a week. Also on a weekly basis, kids learn lessons about nutrition and healthy lifestyles.

The program is based on an evidence-based curriculum issued by the U.S. Soccer Foundation and replicated across the country. In our community, the program has had great success. Over the course of the first year of the program, 90% of the participating youth maintained or decreased their body mass index, 70% maintained or decreased their waist circumference and 90% increased or maintained their aerobic capacity. As a result of the program, students exhibited greater confidence in themselves and have also been moving to engage their families at home by sharing information about healthy lifestyles and nutrition.

The House, Inc. EmpowerMEnt Center

According to the Centers for Disease Control and Prevention, up to one in five children experience a mental disorder in a given year. The Foundation has made several grants to address youth mental health issues in the community. One of these grants was to The House Inc., Student Leadership Center. The House, Inc. is based in Woodbridge, VA and provides innovative out-of-school time programs for pre-teens and teens. Their program, the EmpowerMEnt Center,

received a Howard L. Greenhouse Large Grant Program grant in 2014. With grant support, the EmpowerMEnt Center offered a full continuum of mental health services to underserved youth in Woodbridge, Dale City, Dumfries, Triangle, Manassas, Lake Ridge, and Lorton. The program empowers

youth to take charge of their mental health and emotional well being. The EmpowerMEnt Center promotes positive social and emotional development and intervenes early with students who have or are at risk of developing mental health problems. It also intervenes directly with students with more serious mental health disorders. In 2014-2015, the program reached over 450 students and of the students participating, 76% showed increased self-esteem and decreased aggression and self-inflicted wounds. The students participating in the EmpowerMEnt Center gained coping mechanisms and confidence to make strides in handling their challenges.
